UNDER INDIAN LAW, NONPROFIT ENTITIES SUCH AS SINI ARE ORGANIZED AS CORPORATE ENTITIES WITH VOTING MEMBERS. THE MEMORANDUM OF ASSOCIATION (WHICH IS COMPARABLE TO ARTICLES OF INCORPORATION FOR A CALIFORNIA CORPORATION) PROVIDES THAT THE COMPANY'S PURPOSES ARE EXCLUSIVELY CHARITABLE AND RELIGIOUS, AND SPECIFICALLY PROVIDES, AMONG OTHER THINGS, THAT:

"(1) THE INCOME AND PROPERTY OF THE COMPANY, WHENSOEVER DERIVED, SHALL BE APPLIED SOLELY FOR THE PROMOTION OF ITS OBJECTS [PURPOSES] AS SET FORTH IN THIS MEMORANDUM OF THE COMPANY.

(2) NO PORTION OF THE INCOME OR PROPERTY AFORESAID SHALL BE PAID OR TRANSFERRED, DIRECTLY OR INDIRECTLY, BY WAY OF DIVIDEND, BONUS OR OTHERWISE BY WAY OF PROFIT, TO PERSONS WHO, AT ANY TIME ARE, OR HAVE BEEN MEMBERS OF THE COMPANY OR TO ANY ONE OR MORE OF THEM OR TO ANY PERSON CLAIMING THROUGH ANY ONE OR MORE OF THEM."

IN 2008, AT THE TIME OF THE INITIAL TRANSFER, THE TAXPAYER UNDERSTOOD THAT UNDER INDIAN LAW THE TAXPAYER DID NOT HAVE CONTROL OVER THE SINI GOVERNING BOARD, AND THE TAXPAYER UNDERSTOOD AND INTENDED THAT CONTROL AND GOVERNANCE AUTHORITY WAS RESERVED TO THE INDIAN NATIONALS WHO WERE APPOINTED TO THE BOARD. THE TAXPAYER REPORTED EACH GRANT AS ADDITIONAL CONSIDERATION FOR THE SINI VOTING STOCK AND SHOWED THE AGGREGATE GRANT AMOUNT AS AN ASSET ON ITS FINANCIAL STATEMENTS IN ORDER TO BE CONSISTENT WITH WHAT IT UNDERSTOOD WAS EXPECTED UNDER INDIAN LAW. THERE ARE NO VOTING MEMBERS OR STOCKHOLDERS IN SINI OTHER THAN THE TAXPAYER. THE MEMBERSHIP SHARES ARE NOT FREELY TRANSFERABLE AND HAVE NO MARKET VALUE.

IN LATE DECEMBER, 2011, THE TAXPAYER WAS INFORMED BY INDIAN COUNSEL THAT THE TAXPAYER IN FACT HAD THE AUTHORITY TO APPOINT SUCCESSOR DIRECTORS OF SINI, BY VIRTUE OF THE FACT THAT THE TAXPAYER HOLDS 100% OF THE VOTING POWER IN SINI. THE VOTING MEMBER HAS THE AUTHORITY TO VOTE FOR DIRECTORS BUT DOES NOT HOLD AN ECONOMIC INTEREST, AS WOULD BE THE CASE FOR VOTING STOCK IN A FOR-PROFIT CORPORATION. THE SINI MEMORANDUM OF ASSOCIATION PROHIBITS THE DISTRIBUTION OF EARNINGS, AND ALLOWS DISTRIBUTIONS TO OTHER ENTITIES ONLY FOR PURPOSES RECOGNIZED AS CHARITABLE IN INDIA.

THE TAXPAYER HAS DETERMINED THAT ITS INTEREST IN SINI IS AN INTEREST IN A FOREIGN CORPORATION THAT MAY BE SUBJECT TO THE REPORTING REQUIREMENTS OF INTERNAL REVENUE CODE SECTIONS 6038, 6038B, 6046 AND 31 U.S.C. SECTIONS 5314. FURTHERMORE, OUT OF AN ABUNDANCE OF CAUTION THE TAXPAYER DETERMINED THAT REPORTS RELATING TO THE SINI INTEREST SHOULD BE MADE ON FORMS TD F 90-22.1 FOR THE CALENDAR YEARS 2008 THROUGH THE PRESENT, AND IRS FORM 990 SCHEDULE F, IRS FORM 926, AND IRS FORM 5471 FOR THE FISCAL YEARS ENDING IN 2008 THROUGH THE PRESENT.
