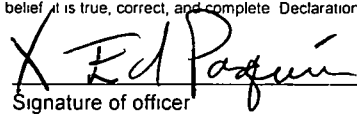
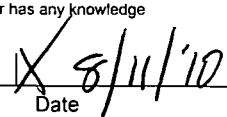

Protection and Advocacy for Individuals with Mental Illness program protects and advocates for the rights of individuals with mental illness and investigates incidents of abuse and neglect of individuals with mental illness if the incidents are reported to the system or if there is probable cause to believe that the incidents occurred. The organization worked on 177 individual cases. Of cases not withdrawn by client or found to be without merit, 78% were resolved favorably for the client.

4b (Code) (Expenses \$ 373989 . including grants of \$ 319019 .) (Revenue \$)

Developmental Disabilities Basic Support and Advocacy program serves to enable persons with developmental disabilities to become independent and productive and integrated into their communities. There were 313 individuals served under this grant.

4c (Code) (Expenses \$ 150282 . including grants of \$ 101420 .) (Revenue \$)

The program purpose is to assist in the establishment of systems for protection and advocacy for the rights of individuals with disabilities that are beyond the scope of the above mentioned programs. There were 137 individuals served under this program and a total of 228 information and referral requests.
