SFP constructs each program based on community need and that gives participants the opportunities to feel the value of helping others and to experience the transformation of their own neighborhoods and communities.

SFP has also developed an Outdoor Learning Lab for K-12 students where they take part in every aspect of creating, implementing, and maintaining an organic garden and the grounds of their school.

Financial Literacy and Community Engagement

In 2008 Service For Peace initiated an innovative Financial Literacy and Community Engagement Pilot After School Program in Stamford and Bridgeport. The impact of this pilot program far exceeded expected results. Twenty-four economics students from Sacred Heart University were trained along with Citi volunteers to conduct eleven training sessions at five moderate income level middle schools in Stamford and one high school in Bridgeport. The training empowered students to learn the importance of savings, along with an awareness of community needs. The long-term efficacy of this training allowed students to become ambassadors of Financial Literacy and Community Engagement in their homes and communities. Latin America and the Caribbean

SFP has established chapters in Nicaragua, Dominican Republic, Honduras, Guatemala, Brazil, Haiti and Paraguay, and is led by a young team whose average age is 26.

Chapters and programs are managed and organized by university students.

All locations except for Haiti and Paraguay have established at least one Community of Peace site. Nicaragua has identified two (Crucero and Comunidad los Zarzales) besides the other two they already have.

Guatemala, Honduras and Brazil have identified one. The Dominican Republic chapter has identified two: Yamasa and Monte Plata.

In 2009, six international Global Peace Maker programs were held: three in the Dominican Republic, and one in Nicaragua, Honduras and Guatemala. During the year, four new Service For Peace student clubs were successfully created: 2 in schools, and 2 in universities.

A significant development in the region took place at this year's United Nations DPI Annual Conference in Mexico, when SFP team members from the LAC region presented the Community of Peace initiative. The theme of this year's conference was "Disarm Now, for Peace and Development" and the SFP presentation was chosen through a highly selective process. LAC staff in the region have developed unique partnerships in their respective nations, partnering with political leaders, governmental institutions, First Ladies offices, Mayor's offices, United Nations Volunteers, UNDP, Rotary Clubs, Partners for the Americas, Wal-Mart, etc.

In Haiti, there was a growing SFP presence through Hispaniola International University, and a Community Clinic. SFP LAC developed an ongoing volunteer program to begin in late October 2009, with the intention of having the first GPM in the country in 2010.

Africa

SFP now has chapters in Cote DIvoire, Democratic Republic of the Congo, Sierra Leone, Ghana, Kenya and Gambia.

2009 was an important year for the SFP Chapter in Cote d'Ivoire. The chapter established higher credibility with the community as a result of conducting four one-day projects and two major international projects. The first one, a Summer of Service program, June 21 to July 10, had 22 European and 20 local participants. During the year, the chapter held a number of Leadership, Service-Learning and Community Service training sessions for students and NGOs. A total number of 200 people were trained.

In terms of partnerships, the chapter increased the number of partners and maintained its good partnerships with UNV and other UN Agencies.

Due to the high success of its training center in Bouake, the former headquarters of the rebel zone, SFP in Cote d'Ivoire plans to open a training center in Abidjan, the capital city. The training center in Bouake opened in 2007. The center trains ex-rebels and youth in peace and community building, and service activities.

A region-wide signature program developed during 2009. This is the Dream Catcher Library project in Mindanao around which the SFP chapters in Nepal, Korea, Thailand and the Philippines are joining forces. This project provides libraries with books and computers for children and youth in difficulties to receive an equal opportunity of education so they can broaden their horizons and find ways to improve their own lives and the life of their communities.

During the course of 2009, both Dr Lenaghan, representing the SFP Board, and Dr Phillips, travelled to Mindanao to lay the groundwork for SFPs work there. SFP developed a peace curriculum that is being used in Mindanao's schools.
