Northeastern Vermont Regional Hospital, Inc is a full service medical/surgical care hospital including special care, pediatrics, and obstetrics. The Hospital makes its services available to approximately 28,000 residents of the greater St. Johnsbury community. A 24-hour emergency room and an ambulatory surgery unit are also available. A new ambulatory surgery unit opened in October 2009. The new unit has space for 16 pre- and post-operative patients. Over 95% of our surgeries and procedures are conducted through day surgery. These services are supported by the laboratory, radiology, rehabilitation, respiratory, and other ancillary services. NVRH is in its sixth year as a Blueprint funded community. It was chosen as the first Medical Home/Community Care Team Pilot in December of 2007, which includes creation of medical homes in 5 primary care practices, a community care team, primary care payment reform, and a health information exchange and chronic care registry.

The operating room at NVRH performed over 3,000 procedures in the fiscal year. Surgical specialties include general surgery, neurosurgery, oral/maxillofacial, otolaryngology, obstetrics/gynecology, orthopedics, ophthalmology, urology, and vascular surgery. Anesthesiologists and nurse anesthetists provide a variety of sedation and pain management techniques. The post-anesthesia care unit provides immediate and individualized post-surgical care with the latest non-invasive, computerized monitoring equipment.

NVRH is one of two Vermont hospitals to have been awarded the international baby-friendly designation by The World Health Organization. This designation supports breast feeding and rooming-in of babies with their mothers. The birth center staff includes a full-time certified lactation consultant. All nurses are CPR and neonatal resuscitation certified. The Center offers monthly programs for women who are considering breast feeding, VBAC classes, and a complimentary car seat safety and education program for the public.
