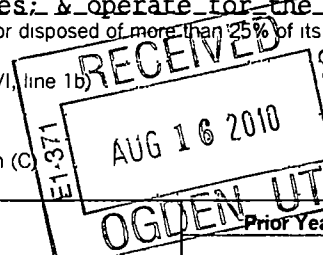

After the audit committee approves the tax return, an electronic message is sent to all Board members with a secured link to the tax return in its final form.
