The organization provides home ownership and rental opportunities to low and moderate income persons through rental of property, acquisition, rehabilitation and sale of properties and development of affordable housing. The organization has 188 apartments available for rent at affordable rates. The organization worked on 19 properties in various stages of rehabilitation including those sold during the year. For properties sold to low and moderate income persons, the organization retained ownership of the land under a land trust model and sold the building with a deed restriction limiting future sales to persons meeting income limits for low and moderate income households. The organization owns 89 parcels of land under the land trust model. The organization worked on 3 properties under development including 1 multi-family residence, 1 affordable housing project to be rented to low and moderate income elderly persons under HUD regulations and 1 low-income housing project to be rented to low and moderate income persons under IRS section 42.
