UBW PRIMARILY WORKS TO TOUR ITS RENOWNED AND AWARDED REPERTORY WORKS NATIONALLY AND INTERNATIONALLY. OVER ITS 25 YEARS, THE COMPANY HAS TOURED EVERY CONTINENT AND THROUGHOUT THE UNITED STATES. DURING FISCAL YEAR 2009, THE COMPANY TOURED WITHIN THE UNITED STATES AND TO GERMANY.

ANOTHER IMPORTANT ACHIEVEMENT OF UBW'S IS COLLABORATING WITH OTHER COMPANIES AND DISCIPLINES. A LARGE-SCALE PROGRAM WAS OUR COLLABORATION WITH THE SENEGALESE DANCE COMPANY, COMPAGNIE JANT-BI. AFTER EXTENSIVE REHEARSAL TOGETHER IN SENEGAL AND THE U.S., THE TWO COMPANIES TOURED THE U.S. IN 2008 INCLUDING A SHOWCASE PREMIERE AT BAM (BROOKLYN ACADEMY OF MUSIC) AS PART OF ITS ACCLAIMED NEXT WAVE FESTIVAL.

THE FLAGSHIP PROGRAM SERVING UBW'S COMMUNITY ENGAGEMENT MISSION IS THE SUMMER LEADERSHIP INSTITUTE, A 10-DAY TRAINING FORUM THAT CONNECTS ARTS AND DANCE PROFESSIONALS AND COMMUNITY-BASED ARTISTS IN A LEARNING EXPERIENCE TO LEVERAGE THE USE OF THE ARTS AS A VEHICLE FOR SOCIAL ACTIVISM AND CIVIC ENGAGEMENT AND TO STRENGTHEN THE NATIONAL NETWORK OF COMMUNITY ARTS PRACTITIONERS. IT BEGAN IN TALLAHASSEE, FLORIDA, IN 1997 AND WAS RE-LAUNCHED IN BROOKLYN IN 2004. IN 2009 UBW MOVED THE INSTITUTE TO NEW ORLEANS TO ASSIST WITH COMMUNITY REBUILDING EFFORTS THERE.

FOUNDED IN 1984 BY CHOREOGRAPHER JAWOLE WILLA JO ZOLLAR, URBAN BUSH WOMEN (UBW) SEEKS TO BRING THE UNTOLD AND UNDER-TOLD HISTORIES AND STORIES OF DISENFRANCHISED PEOPLE TO LIGHT THROUGH DANCE. WE DO THIS FROM A WOMAN-CENTERED PERSPECTIVE AND AS MEMBERS OF THE AFRICAN DIASPORA COMMUNITY IN ORDER TO CREATE A MORE EQUITABLE BALANCE OF POWER IN THE DANCE WORLD AND BEYOND. WE DO THIS BY FACILITATING THE USE OF ART AS A MEANS OF ADDRESSING ISSUES OF SOCIAL JUSTICE AND ENCOURAGING CIVIC ENGAGEMENT.
