Southwestern Vermont Medical Center is a 99 bed hospital that provides inpatient and outpatient medical services and physician services in Bennington and the surrounding area. It is Vermont's only Magnet Hospital for Nursing Excellence. Its services include a fully staffed Emergency Department, including a Chest Pain Unit, Cancer Center, a Family Centered Birth Place, Minimally Invasive and other Surgical Services, a Renal Dialysis Unit, a Full Service Accredited Laboratory, Primary Care and Specialist Physicians. There are satellite campuses in Deerfield Valley and Northshire. Southwestern Vermont Medical Center provides Visiting Nurse Home Health and Hospice services to the Bennington area which include routine home care, wound care, rehabilitation services, infusion services, mother and child care and hospice care for terminally ill patients.
