Community Loan Fund of New Jersey facilitates the flow of money and knowledge to create wealth and well being in underserved communities. In addition to its direct financing activities, Community Loan Fund of NJ provides technical assistance and training programs, conducts research regarding its impact and social return on investment, and disseminates information about itself and the industries it serves. Community Loan Fund of NJ committed 34 loans and investments in the housing, business, and community services sectors during Fiscal 2009, totaling approximately \$24 million. Founded by an impassioned group of affordable housing advocates in 1987, the Community Loan Fund of NJ has expanded to meet the evolving needs of its constituents throughout the State of New Jersey. Since its founding, Community Loan Fund of New Jersey has grown from a loan fund of \$125,000 to a full service financial intermediary with approximately \$140,000,000 of capital under management, and has committed nearly 680 projects totaling more than \$260,000,000 in the housing, community services and business sectors.
