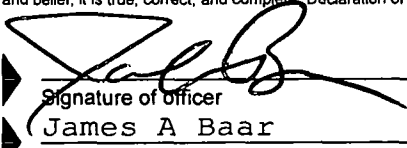

Page 2, Part III, Statement of Program Services, Line 31a:

Manasota BUDS provides scholarships to a special needs summer camp in Bradenton and scholarships to a special needs evaluation center in Jacksonville, Florida called Hope Haven. Each member of Manasota BUDS is eligible for a Hope Haven scholarship. The Hope Haven scholarship is \$200 per family per year. The special needs camp scholarship is open to Down syndrome children that require financial assistance to attend the camp. They do not have to be members of Manasota BUDS for this scholarship. Also included is an annual contribution to NDSS, lending library costs, and family outreach.
