The Family Wellness Program has a team of individuals who are able to provide case management and home visits. The goal of this service is to reduce family stress, improve parenting skills, monitor and enhance child health and development and prevent child abuse and neglect. They are able to provide services to teen parents, expectant mothers, and parents of children new born to six years old. The team includes a health care professional who is available to families to conduct pediatric health assessments. There is also a community resource manager on the team to assist clients in finding resources to help them meet their basic needs, such as rent, utilities, and food. And, the team includes an Early Childhood Mental Health Specialist who strives to provide culturally appropriate mental health services in the areas of counseling, assessments, and referrals. Star Shield offers several youth groups, specifically developed for Native Americans. The purpose of these groups is to give Native American youth a place to connect with other youth, explore Native culture, values, and beliefs, find mentorship from the community, increase self-esteem and self-confidence and come to a better understanding of who they are as Native people. They have also adopted various Native American training curriculums. One of them is a parent training curriculum that draws on the cultural strengths of Native American child rearing. Focused on the positive values of the traditional ways as a model, the curriculum seeks to help parents decide for themselves what kind of parenting skills they will adopt for their own use. Mental Health Program - The Mental Health services are a part of the Association's system of treating the whole person. Mental Health providers are available at all of the Association sites for individual or group counseling and assessments and serve individuals from child to elder. The Mental Health Outreach Team facilitates effective delivery of outreach, engagement and transition services with co-occurring mental health, health and/or alcohol and drug issues.
