Glenwood is devoted to helping people with autism and mental illness achieve their full potential and be productive members of society through evidence-based best practice educational treatment and residential programs. As a result, Glenwood has developed a continuum of services for people with autism and severe mental illness from early childhood through adulthood.

 Autism Division Glenwood provides residential, therapeutic, behavior management, assessment and educational services to children and adolescents with autism and behavioral disorders through its Autism Division. The Autism Division is comprised of three residential programs: McDonough House, Reynolds House and Drummond Center. Glenwood's McDonough House and Reynolds House programs are home-like long-term residential programs for girls and boys ages five to twenty-one with severe autism and/or intellectual disabilities. Drummond Center is a shorter-term assessment and stabilization residential program for girls and boys ages seven to seventeen with an IQ below 70 and/or have been diagnosed with autism. Behavior management is directed toward enhancing the development of the individual and focusing on desirable and adaptive behaviors. This service is necessary to prevent a more restrictive level of care.

4b (Code) (Expenses \$ 4,155,275 including grants of \$ 0) (Revenue \$ 3,718,341)
 Adult Services Glenwood provides residential care, supported employment, vocational, respite, day programs, behavior management and other services to 119 men and women ages 19 and older with autism and mental health disorders. Glenwood's residential care for adults with autism includes six on-campus programs, three community homes, an apartment living program and supported living services. Day program for adults with autism focuses on classes to promote community membership, communication skills, and health and safety. Individual and group classes help adults with autism acquire and maintain skills in areas of daily living. Classes are designed to generate interest and motivate adults with autism to understand themselves and their relationships with others and their environment.

4c (Code) (Expenses \$ 2,731,234 including grants of \$ 0) (Revenue \$ 3,200,253)
 Educational Services Glenwood provides educational treatment to children in its programs through its Allan Cott and Lakeview Schools. Allan Cott serves children ages 5-21 with severe autism. Students at Allan Cott live on campus or in the community. Lakeview School serves the boys in Glenwood's Daniel House I and Daniel House II residential programs.

(Code) (Expenses \$ 1,557,829 including grants of \$ 0) (Revenue \$ 1,554,216)
 Children and Adolescent Campus Daniel House I is a program for boys with severe emotional disorders age 6-12. Daniel House II serves boys with SED ages 10-14. Both Daniel House I and Daniel House II are residential programs providing treatment, education and therapeutic services. Family and Community Services (FACS) is an intensive 4-5 month in-home treatment program for children ages 2-18 with autism and other mental illnesses. FACS provides counseling, parenting classes, behavior management instruction, family support, and basic living skills training to families with children who have developmental delays, autism and/or severe emotional and behavioral problems. At any one time, FACS serves more than 20 families.

 Children and Adolescent Community Glenwood's C & A Community programs provide an array of psychological evaluation services for children and adolescents including psychological evaluations, diagnostic evaluations, family evaluations and evaluations of psychosocial and educational function. While Glenwood specializes in working with individuals with autism spectrum disorders, staff regularly evaluate youth for a variety of issues including Attention-Deficit/Hyperactivity Disorder, Anxiety, Behavior Disorders, Developmental Delay, Intellectual Functioning/Learning Disabilities and Mood Disorders. In addition to assessment and diagnostic services, Glenwood provides professional training on a variety of topics for mental health professionals, educators and others.
