Radiology is the largest program offered to patients at CMCH. Annually the hospital performs over 26,000 procedures, including general radiology services, CT scans, PET scans and an open bore MRI. RADIOLOGY GROSS REVENUE IS \$16,000,000 BEFORE CONTRACTUAL ALLOWANCES AND CHARITY CARE. Surgery is the second largest program offered to patients at CMCH. Over 5,000 procedures are performed annually, with 91.5% of the procedures being outpatient related. SURGERY GROSS REVENUE IS \$9,400,000 BEFORE CONTRACTUAL ALLOWANCES AND CHARITY CARE. Lab is the third largest program offered to patients at CMCH. Over 151,000 are done with 92.6% being outpatient related. LAB GROSS REVENUE IS \$9,600,000 BEFORE CONTRACTUAL ALLOWANCES AND CHARITY CARE.
