community development - The Community Development Department encompasses a broad spectrum of programs for direct client advocacy, community education and systems change and prevention education. Advocacy services provide immediate assistance, information, and support to victims of domestic and sexual violence in crisis seeking help from public agencies. The program responds to victims at hospitals, courts, and police agencies. Turning Points prevention education programs have been evaluated and show an increased understanding by youth of the dynamics of violence and how to help a friend struggling with these issues. The program also serves as an outreach and support link to youth in the audience who have been impacted by violence. Turning Point provides prevention education to over 9,000 youth each year.

**4b** (Code ) (Expenses \$ 753,955 including grants of \$ ) (Revenue \$ )  
Emergency Shelter & Crisis Line Turning Point's shelter provides immediate safety, crisis intervention and resources to families in danger of violence. The shelter program is part of a multi-faceted approach to ending the cycle of violence in families. This program serves approximately 500 women and children annually. Turning Point also provides comprehensive services to children while in shelter and after they leave. Children in shelter receive crisis counseling, tutorial assistance, safety planning, recreation activities, family night activities, support and education, 7 days per week. During the summer months Turning Point provides a summer camp for children in shelter that provide field trips and other fun activities. The program also operates a 24-hour crisis line which provides information, support and crisis intervention to over 10,000 callers per year.

support services - Support Services staff provide individual and group counseling to adult, adolescent and child survivors of domestic and sexual violence. This program serves approximately 700 individuals annually. Counseling services are evaluated by how survivors have increased their feelings of control over their emotions and their life, and their increased knowledge of resources available to them.
