Plan A administers health care benefits to residents of Kent County who do not qualify for any other government sponsored health care programs. The plan contracts with the Michigan Dept of Community Health (MDCH). Benefits and eligibility for this plan are established by MDCH. MDCH pays a set per member per month to Plan A. On average 2,645 average members were served each month.

Plan B administers health care benefits to individuals whose incomes are 150% of poverty and who are not eligible for any government sponsored health care program. The program provides access to basic community based primary care and diagnostics that are not funded by any other means. On average, 1,764 members are served each month.

The Medication Assistance Program provides coordinated access to prescription medications for Kent County residents whose incomes are 200% or less of poverty and what are not eligible for any government sponsored program. It also assists the members in utilizing pharmacy assistance programs provide by pharmaceutical manufacturers. On average, 678 members are served each month.
