Door County Memorial Hospital operates a 25 bed acute care facility, 30 bed extended care facility, physician clinics located in 4 communities and rehabilitation services. In pursuit of our primary exempt purpose of providing health care services Door County Memorial Hospital provides medical care and health information aimed at improving the health status of the communities we serve. Total benefits provided to the community were valued at \$7,734,118 in 2009 which includes the unpaid costs of Medicare. We believe that we have a special duty to meet the needs of the poor, indigent, and medically underserved in our communities and surrounding areas. We have provided care to all patients without regard for the ability to pay. No one is ever turned away based on their ability to pay. In 2009, Door County Memorial Hospital provided a total of \$2,248,493 in Charity Care and \$2,730,003 in unpaid Medicaid costs. Door County Memorial Hospital has an open medical staff with privileges available to all qualified physicians in the area. The board of directors is comprised of independent individuals who are representative of the community from all points on our primary market compass. Door County Memorial Hospital engages in training and education of health care professionals through internship programs. It operates a children’s dental clinic that provides services to uninsured and underinsured children as part of its mission. During 2009, DCMH provided \$714,869 in community health services in areas of education, community based clinical services and healthcare support services. Door County Memorial Hospital participates in government-sponsored health care programs such as Medicaid, Medicare, CHAMPUS, and Tricare. Door County Memorial Hospital’s loss for providing long term care services to the communities was \$2,048,039.
