Westminster Canterbury Foundation raises funds through its Annual fellowship Fund and through Fellowship Endowment for financial assistance (Fellowship) to enter and live for the rest of their lives at Westminster Canterbury Richmond Fellowship also pays their supplemental insurance premiums not covered by their former employer, plus 75% or more of all uncovered medical, dental and pharmacy expenses In FY 2008, 75 men and women among approximately 920 residents were served This does not include an additional 44 men and women served with a PECH fund that is managed by Westminster Canterbury Corporation All financial information provided by prospective residents is analyzed using a software program called FINAID This program uses actuarial tables to project how much, if any, financial assistance may be needed by each prospective resident The analysis is completed without regard to race or religion When financial aid is projected as necessary, specific guidelines are used to determine the extent to which the organization will be able to meet that individual's need Each year the organization retains an actuary to determine the organization's future lifetime monthly financial obligation In this manner, the organization confirms the availability of funds sufficient to support the needs of residents for the rest of their lives
