





The Bethesda Soccer Club (BSC) is a youth soccer club administered by volunteers for the purpose of allowing children to participate in soccer leagues, tournaments, camps and clinics. BSC teams from ages 13 to 19 participate in local and regional soccer competition through various leagues (NCSL, WAGSL, Region 1). The boys and girls compete against over 7,500 players.

4b (Code:) (Expenses \$ 401,335. including grants of \$) (Revenue \$ 492,506.)

BSC sponsors a soccer tournament in November of each year. The tournament attracts 400 teams from the USA, Canada and other countries and allows BSC players to compete against, meet and interact with players from other teams and clubs.

4c (Code:) (Expenses \$ 560,555. including grants of \$ 13,685.) (Revenue \$ 406,576.)

BSC also offers Player Development Program to provide age-appropriate training and playing opportunities for children between 8 and 12 years, designed to foster the joy of play and the development of technical skills.
