The original purposes of MeyerStation, Inc, still remain constant and have been the same since inception—wildlife conservation; preservation; maintaining habitat; and education to the public for the value and care of nature.

Conservation—advice is accepted from all creditable sources for judicious conservation practices in the 137.455 acres comprising the facility area. MeyerStation is one of the very few recognized freshwater wet-lands along the Big Patuxent Rive, a haven and a harbor for migratory and indigenous animals, birds and fish and native plants. The entire area is under a State of Maryland Wildlife Enhancement and Conservation Agreement as well as a State of Maryland Forest Conservation Management Agreement.

Preservation—to use all knowledge and advice available to provide natural preservation strategies for the benefit of animals, birds, fish soil and forest. This is a nature respite area surrounded by burgeoning residential areas and therefore needs constant attention to protect against intrusion on the natural situation.

Habitat—with shrinking feeding material in surrounding areas, assistance is given to wildlife by sowing wild grain as close to natural situation as possible, Food grain disbursed is purchased from County and State conservation sources. Work is done in building and maintaining nesting facilities and protection areas. The habitat needs vary because the area supports a large scope of wildlife—beaver, deer, raccoon, opossum, rabbit, squirrel, woodchuck, fox, wildcat, muskrat and various and sundry small rodents. Birds include great blue heron, varieties of duck, hawk eagles, true bluebirds, Canadian geese, song birds (some endangered), woodpeckers, sparrows, finches, recently re-introduced wild turkeys and others

Education—classes and instruction in natural surrounding are given at no charge to public school children, church groups, 4H, Boy Scouts, Girl Scouts. Audubon Society, Wild Turkey Federation and other organizations use the facility at no charge for nature pursuits.. Numerous discreet nature trails traverse the area, even including one to accommodate wheel-chair visitors, allowing them to witness natural settings.

An important sector of outdoor education is a gun range for the conduct of Hunter Safety courses, (seven lengthy class sessions, all fully attended, were held this fiscal year with nearly 1300 participants/completers). With the very few ranges left in the state that operate for hunter safety purposes, the Maryland DNR voluntarily offered a grant towards keeping the range completely updated and improved. However, this grant was NOT accepted and needed improvements have been accomplished through contributions and volunteers. This range is accredited by the Anne Arundel Country, State of Maryland and Wildlife departments of the Federal Government and serves the general public, Scout troops, and gives use to various police and governmental units.

The area has been on a no-charge reservation system of entry since the beginning of the facility. It serves and accommodates Scouts, FFA, 4H, public and private school classes, interested public, church services on a non-regular basis by visitors, use by professional and governmental organizations at no charge for the purposes of gun-safety instruction, gun sighting use camping, nature classes and meetings.

Russell Meyer, a retired person, spends most of his time, unpaid, administering and operating MeyerStation, Inc. He does the major part of the work, occasionally receiving help from family, officers, directors and also from the attendees that partake of the free use of the facility and then voluntarily offer help.
