Westminster-Canterbury Foundation provided financial assistance to applicants who meet the admission requirements and have served their church and/or community, but lack sufficient resources for admission During the year, 6 residents received entrance fee assistance totaling \$503,144 so they could move into Westminster-Canterbury The Foundation also provides financial assistance for residents, who through no fault of their own, experience financial difficulties and can no longer meet their monthly obligations During the year, an average 24 residents received monthly fee assistance of \$352,029 An additional \$92,666 was paid to residents to assist with medical and other miscellaneous expenses

Westminster-Canterbury Foundation holds several different funds such as the Employee Emergency Fund, the Chapel Fund, the Library Fund, etc These funds are used to provide services to the residents and employees Contributions are collected and the funds are held for expenditures related to these funds The Resident Education Fund provides scholarship grants to employees and children of employees enrolled in a program (usually a degree-granting program) at an accredited institution of higher learning During the year, scholarship grants were awarded to 13 recipients

Westminster-Canterbury Foundation holds funds designated by donors for specific uses These funds are typically transferred on an as needed basis when the request meets the donor designation During the fiscal year ending September 30, 2009, the Foundation transferred \$34,305 to Westminster-Canterbury of Hampton Roads, Inc to support its operations and/or for capital expenditures Westminster-Canterbury Foundation holds funds that were not designated by donors for specific uses These funds are used at the discretion of the Board of Directors and are typically transferred on an as needed basis During the fiscal year ending September 30, 2009, the Foundation transferred \$200,000 to Westminster-Canterbury of Hampton Roads, Inc to support its operations
