Spending policy distributions are based on the related established board policy to provide a consistent process to move funds from the endowment to operating funds on an annual or approved basis. Gifts received by the Foundation Inc and transferred to the Center, from other Foundations are approved by the Foundation Inc Board or per donor request. With the Foundation Inc serving as the endowment fund and support for the Center, TBPAC Foundation Inc provided financial stability in uncertain and challenging times in FY 08/09 and helped maintain the Center's high standards of excellence and creativity as well as providing patrons the ability to continue to enjoy the Center's programs.
