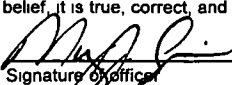
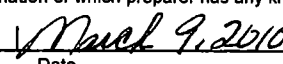
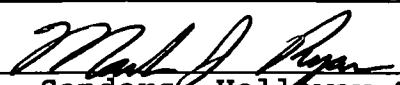

Electronic Filing (e-file).
