


## Shelby County Farm Bureau, Inc. Amendment to By-Laws

The following amendment was made to the By-Laws of the Shelby County Farm Bureau, Inc. the same having been approved by the Board of Directors of same and adopted by two-thirds of those members present at the Annual meeting of the Shelby County Farm Bureau, Inc. on October 2, 2008.

Article III, Section VI, "Dues" is amended to read as follows:  
The joint annual dues for membership in the Shelby County Farm Bureau Inc., the Kentucky Farm Bureau Federation, and the American Farm Bureau Federation shall be \$30.00 per year payable in advance to the Shelby County Farm Bureau, inc. for and on account of the County, State and National Farm Bureaus.
