

STATEMENT 4

EYE INJURY IS THE PRIMARY CLINICAL RESEARCH EMPHASIS OF THE FOUNDATION. IN CONNECTION WITH THIS EMPHASIS, THE FOUNDATION SPONSORS THE ACTIVITIES OF THE AMERICAN SOCIETY OF OCULAR TRAUMA (ASOT), WHICH IS THE LARGEST EYE INJURY DATABASE IN THE WORLD. SINCE RECEIVING SPONSORSHIP BY THE FOUNDATION, ASOT HAS INCREASED FROM 4 TO 40 STATES, NOW COVERING 90 PERCENT OF THE U.S. POPULATION, AND HAS AFFILIATE REGISTRIES IN EIGHT COUNTRIES. THE FOUNDATION ALSO AWARDS GRANTS TO VARIOUS MEDICAL UNIVERSITIES IN AN EFFORT TO ADVANCE CLINICAL RESEARCH. IN A SEVEN YEAR PERIOD, THE FOUNDATION HAS SPONSORED MORE THAN 500 CLINICAL PUBLICATIONS AND PRESENTATIONS AT SCIENTIFIC MEETINGS IN THE U.S. AND INTERNATIONALLY.

AN INTEGRAL PART OF THE FOUNDATION'S MISSION AND ITS PRIMARY EDUCATION COMPONENT IS TO PERPETUATE AND ADVANCE THE LEGACY OF HELEN KELLER. IN 1996, THE FOUNDATION AWARDED A GRANT TO IVY GREEN, THE BIRTHPLACE OF HELEN KELLER, IN TUSCUMBIA, ALABAMA, TO ASSIST WITH VARIOUS ACTIVITIES DURING HER BIRTH MONTH WHERE THOUSANDS OF VISITORS FROM AROUND THE WORLD COME EACH YEAR TO CELEBRATE THE ACHIEVEMENTS OF THE REMARKABLE WOMAN WHO HAS COME TO BE KNOWN AS AMERICA'S FIRST LADY OF COURAGE. IN 1994, KELLER JOHNSON-THOMPSON, GREAT-GREAT NIECE OF HELEN KELLER, JOINED THE STAFF OF THE FOUNDATION TO CREATE AN EDUCATION PROGRAM FOR PUBLIC SCHOOL CHILDREN AND THE GENERAL PUBLIC. IN HER WORK, KELLER TRAVELS THROUGHOUT THE U.S. TEACHING STUDENTS THE LEGACY OF HER GREAT-GREAT AUNT. SHE REGULARLY WORKS WITH ORGANIZATIONS ASSOCIATED WITH LOSS OF SIGHT SUCH AS LIONS INTERNATIONAL AND THE AMERICAN FOUNDATION FOR THE BLIND. THE EDUCATION PROGRAM HAS TOUCHED THE LIVES OF THOUSANDS OF SCHOOL CHILDREN.
