Part III, Statement of Program Service Accomplishments

Public Health

Save Barton Creek Association's (SBCA) primary focus is protecting the water quality of the Barton Springs Edwards Aquifer which is a federally designated solo-source drinking water aquifer for more than 45,000 residents in southern Travis and Hays counties. A City of Austin report confirms that the Colorado River receives a major portion of its flow during dry months from the Aquifer. The efforts of SBCA have a direct and significantly positive impact on the health of all Texas citizens who depend directly or indirectly on the Aquifer and the Colorado River for their drinking water, specifically, the citizens in the following counties: Bastrop, Bell, Bexar, Blanco, Colorado, Comal, Fayette, Frio, Hays, Matagorda, Medina, Travis, Uvalde, Wharton and Williamson counties.

Public Education

Hill Country Oasis, a 32 page booklet produced by SBCA in conjunction with the City of Austin and the Barton Springs Edwards Aquifer Conservation District, is currently being used in classrooms to facilitate instruction about the hydrogeology, flora and fauna of karst aquifers, particularly the Barton Springs Edwards Aquifer.

SBCA conducts free field trips of the Barton Creek Greenbelt and Wilderness Park for school, church and scout groups. These field trips are conducted in a collaborative effort with several nonprofit and corporate partners. Hands-on water quality monitoring is a part of this program. SBCA staff has made presentations to and counseled groups in Concan, Dallas, El Paso, Houston, Uvalde and San Antonio, Texas.

SBCA is a sponsor and partner of the Barton Springs Education Center, a \$450,000. environmental education project housed in the Barton Springs Bathhouse in Zilker Park. Currently, more than one million visitors each year from across the state and around the world visit Zilker Park annually. They benefit from this innovative, "hands-on" educational experience. SBCA provides funding, maintenance assistance and consultation about the scientific aspects of the Center on an ongoing basis.

SBCA has published articles in NewsNotes, an EPA monthly publication and River Network.

Human Services

SBCA conducts free field trips to provide opportunities for citizens of all ages to enjoy the physical and psychological benefits of an urban wilderness experience in a user-friendly educational context. SBCA funds interns for the City of Austin's Earth Camp program, a week-long environmental education program targeted to at-risk youth.
