In establishing this policy, Cook Children's considered the long-term expected return on its endowment. Accordingly, over the long term, Cook Children's expects the current spending policy to allow its endowment to grow at the return hurdle. This is consistent with Cook Children's objective to maintain the purchasing power of endowment assets held in perpetuity or for a specified term, as well as to provide additional real growth through new gifts and investment return.
