Health Advocacy: These projects include trainings in the communities of Fresno, Madera, and Santa Maria California. Trainings consisted of knowing the steps in which to make a change in the area, these are done so that people who who wanted to make a change in how the clinics, hospitals, and health related issues were addressed to the community. Madera members, for example, have spoken with the local clinic and have been meeting on a monthly basis to keep up to date to changes in the procedures of community and clinic relationships.

4b (Code:) (Expenses \$ 199,668 including grants of \$) (Revenue \$)
Education: Educate parents of children ages 0-5 in the county of Monterrey and San Benito California on how to help their children at this stage so that they can become more involved once they reach school age. Home visits are done to play with the children and show the parents what it is that they are teaching their children when palying with certain resources.

4c (Code:) (Expenses \$ 84,931 including grants of \$) (Revenue \$)
Health: Health insurance outreach and enrollment services for low income children ages 0-18. Applications are done in Fresno and Madera California. A cultural component allows CBDIO to provide cooking classes to the indigenous community in order for them to eat healthier while using their cultural food. The development of a garden has been established in two places, Farmersville and Hollister California, to give the community an opportunity to grow organic food and eat healthier.
