General hospital provides rehabilitation and medical services exclusively to patients with spinal cord and traumatic brain injury on both an inpatient and outpatient basis. During the tax year, the hospital provided 27,508 days of inpatient care and 4,279 outpatient visits and incurred these expenses in doing so.

Craig Hospital is designated by NIDRR as a Model System Center for both spinal cord injury and traumatic brain injury. Craig is also the NIDRR National Statistical TBI database for the other model system centers and worked on several other research projects supported by NIH, CDC, other foundations, and industry. During the year, Craig employed a staff of 25 and incurred these expenses to support these critical research projects.
