Cultural Education Program and Tours: The Indian Pueblo Cultural Center (IPCC) developed cultural education curriculum for grades K-12 to serve the Albuquerque school district and surrounding region. The Pueblo art, culture and history taught complements the guided tours of our permanent and changing exhibits, as well as the IPCC murals. Students experience a firsthand look at the 19 Pueblos of New Mexico guided by Pueblo Teaching Artists. The experience culminates in a hands-on art project that relates to Pueblo life. In 2009, IPCC hosted two Pueblo House Summer Camps for Pueblo and other Native American youth, as well as Albuquerque campers. The Camp is an immersion-based program, exploring Pueblo culture, history, art, music, agriculture and cooking. Last, IPCC offers guided and unguided tours of our exhibits and the Pueblo House year round.

Traditional Dances and Artist Demonstrations: The Indian Pueblo Cultural Center (IPCC) offers year round traditional Native American dance performances accompanied by interpretive programming. The dance groups represent most of the 19 Pueblos of New Mexico, as well as several other Native American nations. Each weekend of the year Native American artisans demonstrate their crafts and make available one-of-a-kind pieces for purchase. The IPCC serves as a Gateway to the 19 Pueblos of New Mexico, inviting visitors and students into ancient ways of knowing that never grow old. The number of dance performances and demonstrations increases during two major events in Albuquerque annually: 1) the Gathering of Nations in April; and 2) the Balloon Fiesta in October.

Exhibitions and Affiliated Programs: The Indian Pueblo Cultural Center (IPCC) featured three primary exhibitions in 2009: 1) Eyes of the Eagle, a traveling exhibit from the Global Odyssey Museum at the Centers for Disease Control. This exhibit was a series of four children's books written by Georgia Perez, illustrated by Patrick Rolo and Lisa A. Fifield. Through conversations with animal characters, children learned about healthy living styles based on traditional ways. 2) Celebrating Native Legacies, Works in Clay by renowned Jemez Pueblo sculptor, Kathleen Wall; and 3) Saints of the Pueblos, an exhibit of santero Charles Carrillo's retablos set in the context of Pueblo history. In addition we featured two youth shows, Healthy Bodies Soar and Food in Focus.
