Our scholarships supported students attending entry-level medical imaging and radiation therapy programs, as well as professionals attaining a bachelor's, master's, doctoral or additional certificate in the radiologic sciences. Our research grant award supported the study of high-kilovoltage digital exposure techniques and patient dosimetry, which should improve radiation safety in the clinical area, along with improving patient radiation safety practices. Our ISEA awardees were funded to foster cross-cultural communication and collaboration on best practices among radiologic technologists at conferences in the United

The goal of the Health Care Industry Advisory Council (HCIAC) is to enhance patient care and help increase the body of knowledge in the radiologic sciences by participating in dialogue that shapes the profession and by providing unrestricted support the ASRT Education and Research Foundation. HCIAC members convene at an annual meeting, which encourages open discussion of the latest developments within the industry. To support the coalition, the ASRT Foundation communicates regularly with HCIAC members to discuss important or priority issues.
