THE REMAINING DIRECTORS ARE MADE UP OF REPRESENTATIVES FROM EACH OF THE 13 COUNTY FARM BUREAUS. THE NUMBER OF THE REMAINING DIRECTOR SEATS IS DETERMINED BY THE NUMBER OF AG MEMBERS IN EACH COUNTY. EACH COUNTY WILL HAVE A MINIMUM OF 1 SEAT AND A MAXIMUM OF 4 SEATS. ANNUALLY, THE 13 COUNTY FARM BUREAUS NOMINATE INDIVIDUALS TO SERVE ON THE STATE BOARD. EACH COUNTY FARM BUREAU THEN ELECTS DELEGATES TO THE STATE ANNUAL MEETING; THE NUMBER OF DELEGATES IS ALSO BASED ON THE NUMBER OF AG MEMBERSHIPS IN THEIR RESPECTIVE COUNTIES.
