**1. The Wilderness Society, et al. v. Gale Norton.** Trustees for Alaska represents conservation groups in a federal court challenge to a decision to open 4 million acres of the 23 million acre National Petroleum Reserve-Alaska to competitive oil and gas leasing.

*Status of the case:* The court issued a decision denying Plaintiffs' summary judgment motion. Case closed.

**2. Friends of Mat-Su v. State of Alaska.** Trustees for Alaska represents conservation and community groups in a state court challenge to shallow natural gas leases issued by the State of Alaska in violation of the Alaska Constitution, statutory notice requirements, and state land use planning requirements.

*Status of the case:* The parties negotiated a settlement regarding attorneys' fees whereby the Plaintiffs are not obligated to pay attorneys' fees. Case closed.

**3. State of Connecticut, et al. v. American Elec. Power Co., Inc., et al.** Trustees for Alaska represents the Alaska Inter-Tribal Council and Akiak Native Community as *amici curiae* in a 2<sup>nd</sup> Circuit appeal where the State of Connecticut and other states are suing six major utilities in the Midwest to reduce carbon dioxide emissions. *Amici* support the challenge.

*Status of the case:* The 2<sup>nd</sup> Circuit Court of Appeals overturned the dismissal by the District Court. Case remanded.

**4. Resurrection Bay Conservation Alliance, et al. v. City of Seward.** Trustees for Alaska represents conservation and community groups in a federal court challenge against the City of Seward for discharges of storm water without a permit under the Clean Water Act from the City's small boat harbor and boat repair yard facility at the Seward Marine Industrial Center.

*State of the case:* Oral argument held before the Ninth Circuit, and the case was remanded to the District Court to determine whether to vacate part of



the judgment and to decide the issue of attorneys' fees. Remanded to the District Court.

**5. Defenders of Wildlife, et al. v. State of Alaska.** Trustees for Alaska represents conservation groups in a state court challenge to regulations authorizing significant reductions of predator populations to increase prey populations for sport hunters.

*Status of the case:* Briefing complete and oral argument held in appeal to the Alaska Supreme Court. Decision pending.

**6. Cook Inletkeeper, et al. v. U.S. Environmental Protection Agency, et al.** Trustees for Alaska represents conservation and fishing groups as well as two Native villages in a petition to the U.S. Court of Appeals for the Ninth Circuit challenging the U.S. Environmental Protection Agency's decision to issue a National Pollutant Discharge Elimination System general permit for oil and gas facilities in Cook Inlet under the Clean Water Act.

*Status of the case:* Briefing is complete. Awaiting the scheduling of oral argument in the Ninth Circuit.

**7. Chuitna Citizens NO-COALition, Inc. v. Irwin, et al.** Trustees for Alaska represents Chuitna Citizens NO COALition in an administrative appeal to Alaska Superior Court of Department of Natural Resources Commissioner Irwin's decision to reject an Unsuitable Lands Petition for the Chuitna River watershed.

*Status of the case:* The parties reached a settlement in the case, which provides for resubmitting an Unsuitable Lands Petition for the Chuitna River watershed. Case closed.

**8. Akiak Native Community, et al. v. U.S. Environmental Protection Agency, et al.** Trustees for Alaska represents Akiak Native Community, Nunamta Aulukestai, Nondalton Tribal Council, Curyung Tribal Council, Cook Inletkeeper, Alaska Center for the Environment, Alaska Community Action on Toxics, Center for Biological Diversity, The Center for Water Advocacy, Ekwok Tribal Council, New Stuyahok Traditional Council, and Prince William Soundkeeper in a Ninth Circuit challenge to EPA's decision to delegate the National Pollutant Discharge Elimination System program to the State of Alaska.

*Status of the case:* Briefing complete. Awaiting the scheduling of oral argument in the Ninth Circuit.

**9. Nunamta Aulukestai, et al. v. State, Dep't of Nat. Res.** Trustees for Alaska represents Nunamta Aulukestai, Ricky Delkittie, Sr., Violet Willson, Bella Hammond, and Victor Fischer in a state court constitutional challenge to upland hardrock exploration and water use permitting in Alaska.

*Status of the case:* Complaint and Motion for Preliminary Injunction filed and briefing ongoing.
