Uncompensated Care - During Fiscal Year 2009, Sky Lakes Medical Center continued to see an increase in Charity Care applications and write offs for Bad Debt. By comparison, the economy in Klamath County is poorer than the state of Oregon, including higher unemployment rates and medical indigency. Charges written off under our broad reaching Charity Care policy totaled \$1,820,253. Charges written off as Bad Debt totaled \$2,993,479. As a percentage of charges, these represent, respectively, 3.6% and 5.9%. For the prior year, these percentages were 2.8% and 4.4%.

Educational Support - Sky Lakes Medical Center commits significant dollars and man-hours to benefit educational efforts in and for the community. Among those commitments are the following: Financial contributions to the Oregon Institute of Technology's (OIT) Allied Health Program and to the OIT Nursing Scholarship Fund, Oregon Health Science University affiliated Family Practice Residency Program and Clinic, an RN I training program to include 6 months of one-on-one supervised orientation to the inpatient care areas, awarding of scholarships to community members and/or employees in healthcare-related programs, a hospital department, Learning Resources, dedicated to the education of physicians, employees and community members, commitment to employees acting, either full-time or part-time, as instructors in accredited courses at the high school, community college or university level, stipend payments to students performing work and/or on-the-job training within the hospital setting, tuition reimbursements paid to employees enrolled in college-level coursework, joint participation in a Simulation Laboratory with OIT, free or minimal cost community educational opportunities such as Diabetes Education, Nutrition and other education programs in or for the schools, and Health Fairs.
