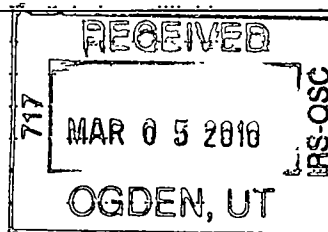

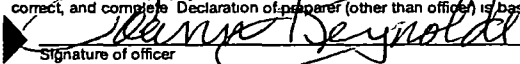

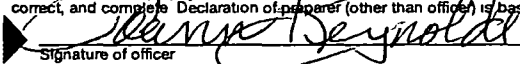

GENERAL MEMBERSHIP IS OPEN TO ANY INDIAN TRIBE OR NATIVE ALASKA CORPORATION INTERESTED IN SUPPORTING THIS MISSION. THE OPERATIONS OF THE COUNCIL ARE DIRECTED BY A BOARD CONSISTING OF ELEVEN PERSONS ELECTED FROM AMONG THE GENERAL MEMBERSHIP.
