



The Asante Foundation's largest program service accomplishment was applying for and being granted a Health Resources and Services Administration (HRSA) grant for Telehealth Networking. This \$750,941 grant allows home care agencies in five counties to have electronic telemetry access to patients in rural areas. Telemetry access helps reduce the number of visits by home health personnel and helps minimize hospital re-admissions and Emergency Room visits.

4b (Code ) (Expenses \$ 209,789. including grants of \$ 164,834.) (Revenue \$ 374,623.)

The Asante Foundation's second largest program service accomplishment was being awarded a second HRSA grant for Rural Services Outreach. This \$374,623 grant will impact the cost and quality of care by using telemonitoring and computerized home medication dispensing systems for rural homecare patients suffering from chronic illnesses.

The Asante Foundation's third largest program service accomplishment was receiving the Care Oregon award. This \$54,000 award will improve patient care processes for glycemic management for diabetes patients and for post-operative nausea and vomiting.

Other cash and in-kind donations help support a laundry list of departments and programs at Rogue Valley Medical Center and Three Rivers Community Hospital.

A copy of the return is to be kept in Asante's Accounting department and another will be kept at Asante's corporate headquarters for public display and copying, as requested.
