The Carl Sagan Center for the Study of Life in the Universe (CSC) specializes in the broad interdisciplinary field of astrobiology, striving to understand all possible forms of life in the universe: past, present & future. We believe we are bringing together some of the best and brightest minds in science today to unlock the mysteries of the cosmos. An example of some of the exciting work our scientists conducted in FY 09 are:
 * Bioengineering designed to inform us about survival in space & how it could be developed to help fuel Earth with renewable energy sources.
 * Investigating the extremes of physics to tell us the long-term prospects for life in the universe, including on Earth.
 * A new understanding of geology at the atomic level is revealing clues about the origins of life & may also yield answers to forecasting earthquakes.
 * Revealing the strange phenomena that take place in ring systems around planets provides insight into how these worlds, and ours, were formed.
 * CSC Research Scientists publish dozens of peer reviewed papers & give presentations about their work to the public.

4b (Code:) (Expenses \$ 3,224,727 including grants of \$) (Revenue \$)
The Allen Telescope Array (ATA) is a unique instrument designed to seek out signals from civilizations elsewhere in the universe while simultaneously conducting other radio astronomy research. Science conducted on the array during FY 09 has resulted in several published papers and presentations at scientific meetings. Additionally, since the ATA is the first instrument of its type, we have begun exploring what unique capabilities it may have to augment the the United States Air Force Space Command's Space Surveillance mission. The ATA could be an important tool to support this mission in areas such as accurate tracking of GPS satellites and tracking objects during daylight hours. These capabilities could have an important impact on improving the Space Command's Space Surveillance Network and therefore increase the overall safety of space.

4c (Code:) (Expenses \$ 1,716,722 including grants of \$) (Revenue \$)
The Center for Education and Public Outreach (EDU) at the SETI Institute develops curriculum and public programs that teach about the potential of life in the universe and other related sciences.
The SETI Institute EDU staff give numerous talks, participate in workshops and seminars and appear in many dozens of media interviews each year. Audiences range from students to professional educators to the general public. During FY 09 the SETI Institute's EDU programs reached thousands of people through both formal & informal education channels and via involvement in trade shows & professional development workshops designed to teach educators about the science the Institute conducts and how to bring it to the classroom environment. 2009 was the fourth year of the SETI Institute's Astrobiology Research Experience for Undergraduates program. This program, which is sponsored by NSF and NASA, pairs students with scientists for summer research projects. Additionally, EDU staff lead the education and public outreach programs for NASA's Kepler and SOFIA missions.

The Center for SETI Research (CSR) is conducting the most comprehensive project dedicated to answering the question, "Are we alone?". Astronomers are using the Allen Telescope Array to search for signs of intelligent extraterrestrial life. During FY 09 we conducted sky survey observations of the Galactic Center region and targeted observations of interesting selected stars. Each year CSR staff give dozens of presentations to a variety of audiences in order to inform both their scientific peers and the general public about their work and accomplishments. CSR staff and their work also appeared in over 50 science documentaries and television and radio programs. Additionally, CSR staff published several peer reviewed papers and wrote, or were featured in, popular articles during FY 09.

When changes to any officer's compensation amount is proposed, the Board, in executive session, reviews the proposed change and approves it by formal board resolution prior to it being granted.
