HSCADV PROVIDES APPROXIMATELY 50 CONFERENCES, SEMINARS, AND WORKSHOPS FOR AN ESTIMATED 900 INDIVIDUALS PER YEAR, FOR A TOTAL OF 3,798 PERSON-HOURS OF TRAINING. THIS TRAINING IS PROVIDED TO DOMESTIC VIOLENCE SERVICE PROVIDERS AND ALLIED AGENCIES AND ENTITIES.

HSCADV PROVIDES STATEWIDE COORDINATION OF PREVENTION AND INTERVENTION SERVICES AND TECHNICAL ASSISTANCE TO 24 MEMBER AGENCIES/PROGRAMS AND NUMEROUS ALLIED AGENCIES AND ENTITIES MORE THAN 45 TIMES PER YEAR, ON A WIDE RANGE OF TOPICS RELATED TO DOMESTIC VIOLENCE.
