ARTICLES OF AMENDMENT OF BY-LAWS
ST. MARY'S HOME

Pursuant to Article X of the By-laws of St. Mary's Home, the following amendments are adopted, to wit:

Article IV: This Corporation amends Article IV, Section 2 by replacing the number of Directors from "no more than (20) members of the Archdiocese of Dubuque, selected and chosen by the Archbishop" to "number of directors at a maximum 7, minimum of 5, appointed by the Archbishop".

Article IV is amended to read as follows:

NUMBER AND APPOINTMENT OF DIRECTORS. The Board of Directors shall consist of the Archbishop, the Vicar General, and the number of directors at a maximum 7, minimum of 5, appointed by the Archbishop, said Board of Directors to have the power to transact all of the corporation's business.

Article V: This Corporation amends Article V, Section 2 removing the requirement that the Vicar General of Dubuque be the Vice-President.

Article V: This Corporation amends Article V, Section 2 removing the term, Executive, from the position of Treasurer.

Article V is amended to read as follows:

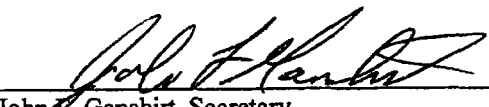
APPOINTMENT OF OFFICERS AND TERM. The officers of the Corporation shall be as follows:
