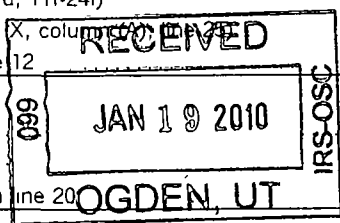

organization to facilitate the construction of affordable housing and the renovation of sub-standard homes within the community.

During the year, the 2000 Roses Foundation continued with the capital improvement program for the client housing facility located at 2000 W. 10th Street. Structural foundation repair valued at \$11,000 were completed. The organization paid for materials while the labor involved was donated.

During the year, in the newly expanded the training facility, the 2000 Roses Foundation began a program to train it's clients in the sewing and alteration business. This program compliments the retail training store by offering minor alterations to the store's customers. Also, clothing from the store is recycled into new cloths, purses, pillows, & etc. The equipment and furniture needed for this program was purchased with funds that were part of a \$5,000 contribution received during the year.

During the year the 2000 Roses Foundation organized and facilitated community cleanups for the 10th Street Historical District. Other community organizations participated in these programs including the City of Dallas and Preservation Dallas.
