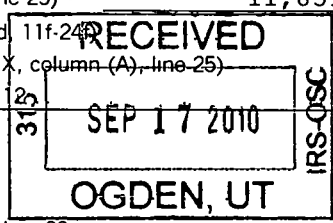

Construction: IN FY 2008, we constructed 15 homes for needy families, In addition, we continued construction on a 20 bed medical facility that will include a center for diabetes treatment.

Food & Medical Aid: Between ten and twenty free medical consultations were provided daily by two physicians. Continuous care for chronically ill patients was also provided. Free meals were provided to patients of Casa Bugambilia and those struggling in the colonias nearby. We have also started an intensive effort to assist with diabetes through special consultations efforts regarding monitoring, wound care, medicine, and nutrition.

Education: Provided tutoring to prepare 5 yr old children for first grade and to assist up to forty children struggling in elementary school.
