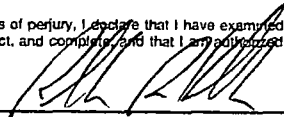

**28. Instruction in Scottish Music and Dance**

Two week-long summer camps provided the following opportunities for study and sharing of expertise:

Classes – daily classes in fiddle, dance, piano, cello, guitar, mandolin, Gaelic singing, rhythm and percussion provided opportunities to study with top performers of traditional Scottish music and dance from the United States and abroad.

Additional Activities – these include evening dances, concerts, informal music sessions and discussion of the history and practice of Scottish fiddling and dancing.

Valley of the Moon Scottish Fiddling School served 230 people.

Alasdair Fraser's Sierra Fiddle Camp served 200 people.

**29. Public Performance of Scottish Music and Dance and Sponsorship of Community Based Performance Groups**

Scottish Fiddlers' Concerts were sponsored and produced by the corporation at the end of both summer camps. There were over 140 fiddlers and other musicians, singers, and dancers performing, for each concert, and approximately 1,600 audience members, total.

A Fiddlers' Rally performance held at the nation's largest Scottish festival in Pleasanton, CA following the Valley of the Moon summer camp featured performances by about 40 of our summer camp participants and instructors, with approximately 8,000-10,000 listeners throughout the 2-day event.

Two amateur performing groups, one in the Los Angeles area and one in the San Francisco Bay area, are sponsored by the corporation. The Los Angeles group produced and presented a concert with approximately 35 performers and a total attendance of approximately 400.

The San Francisco group presented three concerts (Oakland, Salinas, and Napa) with approximately 120 performers and total attendance of approximately 2,000.

In addition, both groups perform at community events, do outreach to local schools, publish newsletters containing transcription of music for the groups' repertoire, and have monthly meetings, workshops, and rehearsals.

**30. Dissemination of Educational Materials**

The corporation provided to members of performing groups and to camp participants, musical transcriptions of Scottish tunes and study tapes or repertoire material. The corporation also obtained and made available to the interested public, educational materials concerning the traditions of Scottish music and dance. Charges for these materials, primarily books, audio and visual recordings, and other items related to practice and performance, are generally well below standard retail mark-up. Net proceeds from the sale of these items enables the corporation to maintain and add to inventory in furtherance of the stated objectives.

The registrar received compensation in return for her services to the corporation as registrar for the two instructional camps, which included: composing and sending out informational flyers, receiving applications, tracking and assisting in the selection of attendees, tracking of deposits, cancellations, and fees, making arrangements for accommodations, composing and compiling information packets for camp attendees, and general coordination of registration at the camps.
