


Head Start is a free preschool program for children ages 3-to-5 years until eligible for kindergarten. It is funded through the Administration of Children and Families (ACF), Office of Head Start, and the State of Maine DHHS, but grantees are expected to raise 20% of the cost of the program through local contributions of cash or in-kind goods and services. The program targets children living at the federal poverty rate but allows enrollment of children from other income levels under strict guidelines. At least 10% of children enrolled must have a diagnosed disability. The Head Start grant supports services to 224 children in center-based programs.

Early Head Start is a program for infants and toddlers and is also

Child Care Services are supported through a state contract that provides child care subsidies for eligible families who are working or in training programs. Child care funds support extended day/year services to Head Start-enrolled children and also subsidize the child care of children not eligible for the Head Start program. The child care subsidies help parents cover the costs of full day/year services on a sliding fee scale basis related to a family's size and income. CFO also offers child care services through a fee for service basis. More than 175 children are supported with child care funds. Regardless of funding source, all children enrolled in CFO's center-based programs are offered the comprehensive services associated with Head Start.

Resource Development Center services are offered to parents seeking child care; child care providers seeking education, training and business supports; and community and business leaders seeking child care solutions. Services to parents include consumer education on selecting child care and referrals to regulated child care providers. Child care providers receive training, technical assistance, professional development counseling, a resource lending library and quarterly newsletter. Community and business leaders are encouraged to enhance early childhood services within their communities and supported in this quest with data and consulting services provided by the Resource Development Center.
