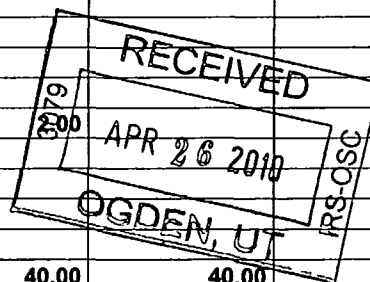

CERTIFICATE OF INCORPORATION
(Nonstock Corporation)

We, the Incorporators, certify that we hereby associate ourselves as a body politic and corporate under the Nonstock Corporation Act of the State of Connecticut.

ARTICLE 1. The name of the corporation is the MICHAELS FOUNDATION, INC.

ARTICLE 2. The nature of the activities to be conducted, or the purposes to be promoted or carried out by the corporation are as follows:

To receive and administer funds and other property for religious, charitable, scientific, literary and educational purposes, all for the public welfare; to aid and assist institutions, associations and societies which are operated solely for religious, charitable, scientific and educational purposes; to aid and assist the sick, aged, helpless and destitute; to establish and support institutions of learning, science and religion.

To provide scholarships for the furtherance of the education of deserving boys and girls and of graduates and undergraduates of colleges and institutions of higher learning, and to establish, support and maintain scholarships and research fellowships at colleges, universities and professional schools not operated for profit.

In general, to promote the physical, cultural and spiritual welfare of men, women and children both directly and by aiding and assisting, institutions wherever located, which are organized and operated exclusively for public, charitable, educational or religious purposes, and for no other purposes.
