


THE PROCESS FOR COMPENSATION OF OTHER KEY EMPOLYEES IS THE EXECUTIVE VICE PRESIDENT USES THE CURRENT LEVEL OF STAFF COMPENSATION AS THE STARTING POINT AND BASES ADJUSTMENTS PRIMARILY ON BENCHMARKING TO OTHER AGC CHAPTER COMPENSATION SURVEYS AND THE INDIVIDUAL'S PERFORMANCE. THE FISCAL AFFAIRS COMMITTEE REVIEWS THE RECOMMENDED STAFF COMPENSATION AND MAKES THEIR RECOMMENDATIONS.
