Based on the health needs assessment compiled by Eastern Maine Medical Center a collaborative venture was created between three major healthcare providers, including St Joseph Healthcare, within the geographic service area was created. This group has utilized the health needs assessment data to collaboratively address needs within the service area. This has led to a reduction in duplicative initiatives and an enhanced working relationship between the three participating health care providers. In addition, St Joseph Healthcare initiated an independent survey focusing on the health needs and preferences of adults within the primary and secondary service areas. This information is reviewed and utilized as Organization strategic planning is conducted to ensure that future planning helps meet the identified health needs and preferences of those residing within the service area.

Our immediate primary and secondary service areas, comprising 76.51% of our admissions, include all of Penobscot County, and the towns of Bucksport and Ellsworth in Hancock County and the town of Milo in Piscataquis County. St. Joseph Hospital's specific age demographic breakdown based on a 6 month admission period in 2009 showed that 40% of admitted patients were less than 65 years of age, with 60% of admitted patients 65 years of age and older. The US Census reports that within St. Joseph Healthcare's immediate primary service area (Penobscot County) demographics include a population that is 96% white, 51% female, 86% who are high school graduates, 70% who own a home, and that the County has a median household income of \$42,704.
