**Land Conservation: RRCT continued to work with community leaders to establish a preserve in the Town of New Gloucester, ME through the acquisition of 7 contiguous parcels. When complete, this project will connect to a larger, existing trail system, providing the public with an outstanding recreational benefit within 20 miles of downtown Portland, Maine. Due to economic circumstances beyond our control, the project is taking longer to complete than expected. Fund raising and due diligence activities continued into 2010.**

**Stewardship of Real Estate Interests: RRCT monitored its easement holdings and educated landowners about restrictions when necessary. RRCT improved its record keeping and documentation of fee and easement lands by initiating a GIS database of holdings. RRCT also developed management plans for several properties so as to improve public access and the control of invasive species. All these activities included organizing volunteers. Other stewardship work included becoming familiar with 15 conservation easements and one fee owned property that RRCT acquired through its merger with the Pownal Land Trust (documents with IRS yet to be completed, State of Maine documents filed and accepted)**
