

Part III

Our organizations primary exempt purpose is improving the education, health and safety of all children in our school community.

- Line 28: Student Enrichment Programs: We provided funds to provide after-school classes for an estimated 120 students in grades K-5; contributed to the transportation cost for the 5-8 Grade Field Experience overnight trips; contributed to field trip costs. We will continue all of these programs in the future. We plan to expand these programs, and to provide more scholarship help for students to attend after-school classes & field trips.
- Line 29: Student Enrichment / Educational Programs: Contributed to the school to offset partial cost of a tutor whose services were used by an estimated 35-50 students throughout the year; provided up to \$100 in reimbursements for each full-time instructor for classroom projects; used proceeds from Scholastic Book Fair to provide books for the library. As Jane Addams K-8 is a new school, we started with only a few of these types of programs during this first year, and anticipate expanding these existing programs. We plan to add others programs consistent with the school curriculum for the purpose of helping students in their academic environment in the coming years.
- Line 30: Student / Parent Involvement Programs: These programs to encourage parent participation with their children in the school environment include providing snacks during the family-oriented events such as curriculum night, math night & science fair events; field day; volunteer appreciation; membership meeting speaker appreciation; teacher appreciation week events. We are hosting more family events next year such as movie nights & parent socials.
- Line 31: Miscellaneous Programs: School Spirit; building & grounds beautification projects; open house tour expenses to recruit new students; Pennies for Peace fundraiser for underprivileged children.
