THIS HAS BECOME A MAJOR ANNUAL FUND-RAISING EVENT FOR MOST OF THESE ORGANIZATIONS. APPROXIMATELY 11 GROUPS BENEFIT FROM THIS EVENT.

THE PRODUCTS SOLD IN THE GENERAL STORE ARE TAKEN ON A CONSIGNMENT BASIS. THE GENERAL STORE HAS BENEFITED APPROXIMATELY 30 SMALL NEW HAMPSHIRE BUSINESSES.

IN ADDITION TO PROMOTING AGRICULTURE IN NEW HAMPSHIRE AT THE EVENT ANY PROFITS MADE ARE GIVEN BACK TO THE AGRICULTURAL COMMUNITY IN THE FORM OF GRANTS.
