Public Education

EHD conducts public health education activities for the purpose of improving preconception and prenatal health. Some activities are specifically intended to equip education professionals and public libraries with educational resources while others are intended for the general public.

EHD donated a total of nearly 9,000 free resource packets in Colorado (each with our DVD, The Biology of Prenatal Development, a brochure/poster, and letter introducing our health campaign and free web resources) to middle- and high-school educators (leaders and classroom teachers), college professors, and public libraries across Colorado. Sales of DVDs and study guides are also an important part of this effort.

EHD also further developed educational resources at www.ehd.org which feature a variety of free educational resources for pregnant women, students, teachers, and others.

All web resources were continuously accessible free of charge.

Creation of Spanish Website
