



Part III Statement of Program Service Accomplishments

1. The E. F. Schumacher Society continued to make improvements to its Library building including a new roof, improved insulation, and a doubling of supporting beams. New donations of materials were also received. Interns under the direction of staff completed cataloguing E. F. Schumacher's archives and personal papers. Researchers accessed the Library's computer index of over 15,000 books and the archives over the Internet. Students from universities throughout the Northeast have used the Library for research, as have other visitors to the building. In addition to the computer catalogue, staff maintain a physical card catalogue for the collection.
2. The Schumacher Society's web site was expanded to contain new texts of the collected E. F. Schumacher Society lectures on subjects relating to the environment, sustainable communities, and citizen-based approaches to solving local problems. The Society's eNewsletters were posted in blog form as well as on the website. The MANAS journal related website was used as study material for groups in their homes. The BerkShares website continues to be updated to include extensive media coverage of the BerkShares model economic development program and related educational materials. Together the three educational websites of the E. F. Schumacher Society received a total of seven million hits in 2009 according to statistics provided by our web host.
3. The Twenty-Ninth Annual Schumacher Lectures were held in Stockbridge, Massachusetts in cooperation with regional organizations. The 300-person audience heard addresses on environmental, social and economic issues by Bill McKibben, Benjamin Barber, and Aliza Gravitiz. Audio and printed transcript of the talks were placed on the Society's website.
4. The Society's publication program continued with editing and printing of the Schumacher Lectures made available through the Society's Publication Service and over the Internet. Pamphlets which had gone out of print were reprinted during the year. The Lectures circulated broadly on the internet and were used as texts in college classrooms.
5. The Society continued to provide education services to other regions about a "Small is Beautiful" approach to economic and cultural renewal, traveling to conferences around the country, speaking, and providing information via phone and publications.
6. Executive Director, Susan Witt, was invited and completed an essay for an upcoming book on Jane Jacobs, describing her economic concepts.

7. The E. F. Schumacher Society provided research assistance, development, and administrative oversight for BerkShares, a local currency designed to educate citizens about the importance of vibrant, self-sufficient, regional economies. The Society developed literature about the program, strategized on future development, hosted international media wishing to cover the story, and engaged with representatives of other communities wishing to develop similar programs in their own areas. The program continues to receive international media attention, educating about the import role of strong local economies in building sustainable communities.

8. The international media attention to the Society's programs has led staff to explore close collaboration with other organizations working in the field of community economics to provide a broader context for the Society's programs and maximize media interest in the subject. As part of this initiative, the Society expanded its board to include economists and those applying new economic thinking.

9. The acquisition and restoration of Guilder House in 2008 enabled the Society to engage three interns during the year who worked on the Library, BerkShares, web development, new collaborations, and new media outreach.
